### **FROM THE PRESIDENTS PEN**





#### **Sub Branch News**

2022 has been a very successful one for the Sub Branch. Membership numbers have held up well and our trading operations have produced a pleasing surplus. Financially the Sub Branch is in a very strong position.

Unfortunately, we have lost a number of our members succumbing to old age. Most notably Robbie Waterson who contributed so much to the Sub Branch as its long time Appeals Officer and to the repartee in the ANZAC bar most lunch times. He will be sorely missed and our best wishes go to Silvia whose own contribution to the Women's Auxiliary has been immense.

The wide range of programs for members run in the main by volunteers proceeded during the year and contributed much to the life of the Sub Branch. This program is supplemented by entertainment activities coordinated by the manager and day trips organised by the Women's Auxiliary using the Sub Branch buses.

The financial focus in 2022 was to strengthen our position so expenditure was mainly directed down paying the bank loan, to paying for the electronic gaming machines which was necessary under the gaming contract arrangements and to essential maintenance with some minor upgrading to the electronics systems. Looking forward we also need to build a reserve of funds to finance the fit out the new facility once the rebuild has been completed and a start has been made to cover this provision. During the year we worked:

#### **Ordnance Field Park (OFP) South Vietnam Reunion**

The Sub Branch is hosting the OFP Association reunion from the 23<sup>rd</sup> to 26<sup>th</sup> of April. This coincides with our ANZAC commemorations and will mark 50 years since the last Australian was withdrawn from South Vietnam.

#### Ringwood WW1 Armistice Heritage Walk

In 2018, Australia celebrated the Centenary of the Armistice of World War I. The Australian Government, through the Department of Veteran's Affairs (DVA), established an Armistice Centenary Grant Program, which has provided the funds to establish the Ringwood World War 1 Armistice Heritage Walk.

The walk has ten signs, with details regarding the significance of World War I and the connection it has to the Ringwood community. The signs are located in chronological order, from 1914 to 1918, as the walk progresses up Maroondah Highway from the Clocktower, turning into Station Street and returning to the Clocktower.

This memorial walk acknowledges and commemorates those from Ringwood who served Australia and its allies in wars, conflicts and peace operations, and the effect of this in the local community of Ringwood. We have worked with the Maroondah City Council and the Ringwood Historical Society to help bring this project to reality.

This important historical and commemorative project involved a number of community groups and tells the social history of the community of Ringwood over 100 years ago, the trauma they endured and the sad stories and remarkable survival of families and individuals.

#### **Deakin Award for Services to the Community**

We nominated Margaret Handte for an award in the 2022 round to recognise her work with the Army Reserve, ADF Cadets and as one of our Bereavement Officers. She was successful in being recognised winning the open category and was awarded the overall Deakin award for 2022.

#### **State RSL Matters**

#### FUNDING THE STATE OFFICE

A State working group to develop a funding arrangement replacing the one which was part of the previous gaming contract proposed a revised basis for levying 10A Sub Branches to fund the State Office. The revised formula takes into account membership numbers, revenue and numbers of EGMs. The impost on Ringwood is slightly more than we had been paying and the Committee signed up to the amended funding agreement which is set at \$138,000 for 2023.

#### ELECTORAL REFORM ADVISORY GROUP (ERAG)

This task group looked at how the State Executive is elected. It made a number of sensible suggestions concerning the number and length of tenure but its work was largely ignored.

#### NEW MEMBERSHIP SYSTEM

With the completion of the last gaming contract, the membership system which was part of the contract ceased. Since then we have been in ongoing discussions concerning membership of the League and the Sub Branch. We were somewhat alarmed when one of our members erroneously advised by an employee at the State Branch office "that the Sub Branch has separated from the Returned Services League Victoria". No such decision has been made by the Ringwood Sub Branch Committee and the Committee has not and has no plans in the future to initiate any action to separate or disaffiliate from the League. All our service and affiliate members are and remain members of the League and all categories of members enjoy access to and reciprocal rights from other Sub Branches.

What the Ringwood Sub Branch Committee has decided is that the Sub Branch will not subscribe to the new state membership system. This decision is about the way the administration of RSL Victoria members is carried out not whether Ringwood Sub Branch members are or are not Victorian members of the League. It is based on two major factors;

#### **Gaming Operations:**

The new membership system is a component of the IGT gaming system which the State Branch has adopted to manage its gaming (i.e. poker machine) services and by which it also manages its "RSL Rewards" promotions. The view of the Committee is that the State Branch office should not become a gaming services provider but should instead focus on the central purposes for which the League was established (i.e., advocating and providing wellbeing support for veterans and their families). The Committee had also decided some time ago to withdraw from this rewards system believing a local sub branch-based rewards promotion would be of greater benefit to its members.

#### Cost::

The Sub Branch has committed to continue to pay affiliation fees (League Support Fee - LSF) to RSL Victoria. These fees for 2023 are set at some \$138,000 and are projected to increase by inflation in 2024 and 2025. The State Branch has set its fee for the membership system at some \$14,000 (in addition to the LSF) system. The State membership system is incompatible with the sub branch systems and to fully integrate it would mean a complete replacement of these that would cost the Sub Branch in excess of \$160,000 initially with ongoing licence costs of another \$22,000 per year plus additional costs to replace/reprogram point of sale registers etc and retrain staff. The Committee did not feel it could justify the expenditure of members funds for this.

The Sub Branch is still discussing with the State Branch on how to administer Ringwood based League members and has proposed alternatives that we hope will provide a basis for the future administration of its members and be accepted by the State Branch. Never the less Sub Branch members are being issued with a card that is fully operable within the premises and we expect the continued issue of the Victorian RSL card by State Branch to all League members (service & affiliates) will occur.

Reciprocal rights are part of the State by-laws and administration of these is up to each sub branch. For example, the Ringwood Sub Branch can be accessed with a State RSL card but it will issue a "visiting RSL member" card to League members visiting the sub branch whose State issued card is incompatible with our systems to enable the access to member benefits including discounts.

#### **Redevelopment Project**

The project is proceeding albeit very slowly bearing in mind the prevailing economic conditions, the state of the real estate market, supply chain issues and the shortage of tradespeople. The Committee as part of its risk mitigation strategy, has agreed to slowing it down as it is monitoring the risks in the construction industry at the moment. It has no interest in pushing forward prematurely in view of the difficulties witnessed among a number of both small and large construction firms.

#### **A Final Word**

Like everyone else, I'm looking forward to 2023 being a year of consolidation.

On behalf of the Committee and members of the Sub Branch I would like to express my appreciation for the dedication and work of the Manager and his staff during the past year.

Once again thank you for your continued support and keep well in 2023.

# **SUPPORT TO THE VETERAN AND COMMUNITY**

#### Sub Branch Veteran & Community Support

In 2022 the welfare and support work of the Sub Branch continued as focus of the Sub Branch.

\* During 2022 we helped many veterans in the Eastern Metropolitan Region of Melbourne. Our pension advocates provided assistance with their claims for support from the Department of Veterans' Affairs. This is a highly valued service at the core of our objectives as an RSL Sub Branch. The Welfare Coordinator and her team of volunteers provided much needed welfare and practical support to veterans in our region as well as to the older and less mobile members of the Sub Branch. These volunteer services included in-home and hospital support, welfare help, transport assistance, mobility aids as well as minor house and garden maintenance etc. These services have a particular value for our frailer members but also for others in our community who need our help. This volunteer support to the Maroondah community was costed out at \$45,400

Other volunteer activities such conducting Bingo, Friendly Fridays, Mobility Classes, "Boxersize" etc were provided at a value of \$34,560

We conducted commemorative services for the Ringwood community to mark ANZAC and Remembrance Days at the Ringwood Clock Tower Memorial Park.

Our normal remembrance services with local football teams spread from Mitcham to East Ringwood were not possible due to the COVID restrictions.

\* We were able to provide bursaries and assistance worth \$3,000 for children attending Ringwood, Heathmont and Norwood Secondary Colleges.

\* We supported the Maroondah Brass and the Ringwood Pipe Bands with sponsorship of \$5,000 each even though their activities were suspended. These bands provide a valued component of our commemoration services.

\* We provided support to members of the Sub Branch with subsidised meals and refreshments, and other "in club" activities designed to combat social isolation and enhance camaraderie among veterans and their families. The cost for these was approximately \$287,421.

\* We provided the Welfare/Courtesy Bus for members benefit as part of our social inclusion program at a cost of \$55,278.

\* We provided sponsorship of and support for the Women's Auxiliary, War Widows, the Day Club and Sub Branch Sporting Sub Sections worth \$20,262.

\* Sponsorship to the Ringwood Football Club, etc \$16,500.

We gave local community groups access to our facilities at either no charge or heavily discounted prices as part of our support to the wider Maroondah community \$102,354

We contributed about \$2,727,158 to the local community in goods and services purchased and employment of 50 staff from the surrounding community.

The Sub Branch contributed \$224,439 towards funding the welfare and other work of the State Branch office.

In total we contributed some \$3,499,872 worth of benefits to our veterans and community in 2022.

#### **Other Activities**

#### **Veterans' Games**

An exciting initiative by Heston Russell (Veterans Support Force) is the coming <u>veterans'</u> <u>games</u>. This carnival of sport will be the inaugural launch of an annual event designed to celebrate and showcase the skills and excellence of our Veteran Community in a format that is exciting and engaging for the wider public.

Competitions will include a Team Obstacle Course challenge, Team Tug-of-War, and a number of other Military styled activities designed to test the teamwork and problem-solving skill-sets of competitors. Veterans (current and former serving) will be required to form and register their own team of eight (8) and pass a basic fitness test in order to compete.

This is a first of its kind type of event and will be held during the period 29 September – 02 October on the Gold Coast. The format will consist of Elimination Heats followed by the Finals Day to be held on Monday 02 October 2023.

The Sub Branch is seeking to sponsor a team. Further information can be gained from Jason Isaac or Neil Trigwell via reception.



# **WELFARE AND PENSION**

The welfare and pension office continue to assist members and veterans. I have had over one hundred enquiries to the welfare office alone with a number of diverse queries where I have made many referrals to varied services required by these members.

Our wonderful pension advocates, Kevan and Ian, have been kept busy with appointments on Thursdays and I would like to say thank you to them for all the hard work they do in assisting our ex-veterans. I would also like to mention Heather and Linda the admin assistants that helped in the pension office. These ladies work behind the scenes preparing the files for clients, and thank them for their time during the past year.

Our wellbeing groups continue with the Strength and Mobility Class, Bingo, Friendly Fridays and now this year a small craft group every second Tuesday afternoon. There is also a free boxing class held on Wednesday evenings.

If you are interested in participating in any of these groups, or to become a volunteer for the RSL please let us know.

We receive a large number of requests from families of deceased veterans to conduct the RSL component at the service. Thanks to Margaret, our funeral officer, we can assist these families at their loved one's funerals.

This Christmas we have put together some fantastic care bags for the homeless and certain members of the club.

We are very fortunate to be able to deliver these the last week in December, and donated our Care bags to Uniting Care at Ringwood.

Volunteers continue to provide support to the needs of others, to the RSL community and the selling of the badges and poppies, we thank all that our volunteers do for us.

### **TREASURERS REPORT 2022**

It is my privilege that I provide this report for the financial year ending 31<sup>st</sup> December 2022. The report is based on the final audited figures, copies of which will be provided at the Annual General Meeting.



The club had struggled over the past few years due to the disruption caused by the COVD pandemic, in fact the 2022 financial year has been the first full year of uninterrupted trading at our club since the 2019 financial year.

I am pleased to report to you that, for the financial year ending 31<sup>st</sup> December 2022, our club made a net profit of **\$999,747**. This is an incredible outcome, and, in my opinion, the result reflects the actions, attitude, service and effort put in by our management team and staff during the year. It also reflects on you, our members, for supporting your club and making it a great place to be.

Let me focus on some highlights:

- **1**. The ANZAC Lounge traded over 60% up on the previous year.
- 2. The Bistro growth was nearly 10 times more than last year.

3. Expenses across the board were in line with expectations.

4. During the month of August, we purchased all our floor stock of gaming machines from TABCORP for \$883,000. The amount was financed by the clubs internal cash flow.

5. The clubs cash reserves remain very strong sitting at 942,000 as of the  $31^{st}$  of December 2022.

Looking ahead to 2023, I feel confident that the club will continue to remain in strong financial position.

I would personally like acknowledge the good work done by the management and staff of the Ringwood RSL Sub Branch and in particular, I'd like to thank our General Manager Wayne Chisolm and our accounts staff for the support they have given me in performing my role as treasurer. I also like to thank the committee and members of the club for everything they do and to make this a great club.

Looking forward to working with you all again in 2023.

# **OASIS VETERAN & FAMILY SUPPORT CENTRE**

Hello everyone, the team in the Advocacy department have been very busy since mid-January with claims and claim enquiries.

Christmas and New Year can be a great time of year but unfortunately some of our veteran community pass away, namely older veterans who just want to make it to Christmas.

#### Veteran Deaths

In the unfortunate event your partner passes away, please contact us here at the Oasis Veteran Support Centre. If your partner has a gold card embossed TPI, EDA all you need to do is call DVA and inform them of the death and supply them with their gold health card number and a death certificate.

#### Keeping a list of Accepted Disabilities

DVA Health Cards are normally issued to Veterans as a White or Gold card. To assist your partner Veterans are advised that they should keep a list with all their accepted conditions on it. The list is available on your mygov account if you have a link to the Department of Veteran Affairs. The list will also be on your decision letter from DVA. If you do not have a list or cannot access it, come along to the Oasis Veteran Support Centre and we will print one off for you.

Why is keeping this list important? The rationale is that if you die from a Defence caused injury your partner may be entitled to a widow or widower's pension.

#### Have you had your DVA claims reassessed.

When was the last time your Defence caused claims were assessed?

We recommend that you have multiple claims assessed every 5 years.

Injuries and illnesses change and some injuries/illness lead to another.

Example 1 - A broken leg may get arthritis within 10-20 years. Example 2 - Your Solar keratosis may have become worse, and a BCC may have formed.

#### **Mental Health issues**

There has been a large upsurge in Mental Health in the defence community. If you are under 65 years and cannot work more than 8 hours due to your defence caused mental health injury you may meet the eligibility criteria under the DRCA and MRCA Act for Veteran Payments. You will need to provide a medical certificate. Contact the Oasis Veteran Support Centre.


### **RINGWOOD RSL WAR WIDOWS**

### **DEVELOPMENT REPORT**

Whilst nothing seems to be happening in the development project, be assured that there is a lot going on.

We are in the phase of the project where we need to apply for the relevant permits and approvals to proceed. No physical action can be taken until those permits and approvals are obtained. Our development partners are working diligently on those and will continue to do so. The approval application process could take in excess of 12 months depending on the response of the Maroondah City Council to the application. We had planned on this time frame.

Members were advised very early in the project planning process that there would be periods such as this when nothing appears to be happening, but the committee and the developers are communicating frequently to ensure the committee is fully up to date on progress.

In the most recent meeting between the committee and the developers (December), they expressed their commitment to the project through until its completion. This commitment is in the context of the major issues facing the building industry where the cost of building supplies and materials have risen significantly and are in limited supply and the current shortage of the required trades people for major building projects. These issues are ones that could not be foreseen prior to COVID and the resulting impact it has had on all sectors of supply, materials and expertise and the planned time frame for projects such as ours.

The committee will keep members updated on significant developments as they occur.
